Scuba is my walking companion and we have logged hundreds of miles together. In the summertime, Scuba always enjoys a couple human treats: corn on the cob and a refreshing wedge of watermelon. His most favorite treat is a peanut butter flavor doggie ice cream. And speaking of peanut butter, Scuba likes to take his occasional meds dipped in a spoonful of smooth peanut butter. Under the care and guidance of Suffield Veterinary Hospital since puppyhood, Scuba enjoys a healthy and active life. He recently had an episode of vestibular disease, a middle ear inflammation that causes wobbling and loss of balance. A follow-up visit to SVH revealed that Scuba has a partial ligament tear

in his right knee as well as arthritis on the same knee and lower spine. Our poor baby! For treatment, Dr. Burke recommended enrolling Scuba into their laser therapy program. Therapeutic laser treatments, each lasting only a few minutes, have given him tremendous relief from his joint pain and weakness. He is now walking better than he has in over a year.

My husband, and I and of course, Scuba too, are very thankful for the special relationship we continue to have with SVH."
